MORE THAN 250 ARTISTS PARADE THEIR WHEELED CREATIONS FOR AWED ONLOOKERS IN A CELEBRATION OF THE UBIQUITOUS AUTOMOBILE THAT TURNS HOUSTON'S STREETS INTO AN OPEN-AIR MUSEUM. THE HOUSTON ART CAR PARADE HAS GENERATED PRESS IN DER SPIEGAL, SMITHSONIAN, LIFE, VANITY FAIR, AUTOWEEK, AND THE BBC'S TOP GEAR, WITH EXTENSIVE FEATURE STORIES IN NEWSPAPERS SUCH AS THE NEW YORK TIMES, THE WASHINGTON POST, LOS ANGELES TIMES, CHICAGO TRIBUNE, DETROIT FREE PRESS, AND USA TODAY, NOT TO MENTION COVERAGE FROM FRENCH, JAPANESE, BRITISH, KOREAN, AND GERMAN TELEVISION CREWS.
